#### Further information on data protection:

Image data and personal details (surname, first name, contact details if applicable) are collected directly from you as part of the recording process. The primary basis for processing your personal data is your consent. In addition, we process your data on the basis of our overriding legitimate interests in the effective internal and external documentation and communication of our scientific activities. In this case, the purposes of processing are internal communication, public relations of Hereon and science communication.

Note on special categories of personal data: Under the GDPR, information that reveals racial and ethnic origin, political opinions, religious or ideological beliefs or health data is subject to special protection. Since even glasses, walking aids, headgear or skin color may count as special category data, the consent obtained must therefore necessarily also extend to this information.
